- Students who fail to get visa for completing the later part of the programme at Demontfort University, Leicester, UK shall be allowed to complete the entire programme at Devi Ahilya Vishwavidyalya, Indore, M.P. and shall be awarded Degree by Devi Ahilya Vishwavidyalya, Indore, M.P.
- The institution should clearly mention the above two points in the prospectus for the awareness of the prospective students and their parents
- 4 The institution must appoint Principal and other faculty members as per AICTF Norms with pay scales as prescribed by AICTE before making any admission.
- All the required Laboratories/Workshops/Machineries/Equipments, as per approved syllabil of the collaborating Foreign University, must be operational before making admissions.
- 6. No excess admission shall be made by the institution during the academic year.
- The approval is valid for the academic year 2008-09. If no further extension of AICTE
 approval is received beyond the mentioned academic year, this approval letter will not
 be valid for making any admission for subsequent year.
- The approved course shall commence as per the academic calendar prescribed by the collaborating Foreign University.
- .9 No admission shall be made by the institution, contrary to the guidelines provided by the collaborating Foreign University for the adademic session 2008-09
- 10 You are required to submit a Joint Fixed Deposit created for a period of 8 years in the name of the President/Chairman of the Applicant Society/Trust and the concerned Regional Officer of AICTE for an amount of Rs. 15 lakhs.
- 11. The original Joint Fixed Deposit receipt shall be kept under the custody of the proposed Institution, a copy of the joint Fixed Deposit receipt shall be submitted to the concerned Regional Office of the AICTE along with an affidavit on non-judicial stamp paper of prescribed value stating that the Joint Fixed Deposit shall not be encashed or modified without prior consent of AICTE. The Regional Officer, AICTE shall also instruct the concerned Bank not to allow any encashment/modification of fixed deposit and grant of loan against the deposit without the prior encashment of AICTE.
- 12. The interest accrued on the fixed deposit shall be credited to the concerned Institution on yearly basis and shall be utilized for award of scholarship to the students
- 13 The Joint Fixed Deposit shall be permitted to be encashed on expiry of the term of the Fixed Deposit. However, the term of the fixed deposit could be extended for a further period as may be decided on case to case basis and/or forfeited in case of any violation of norms, conditions and requirements and/or non-performance by the institution and/or complaints against the institution.
- 14. In exercise of power conferred under 10(p) of the AICTE Act, AICTE may inspect the institution any time it may doern fit to verify the progress/compliance or for any other purpose.

The institution is required to submit two copies of the Compliance Report indicating the rectification of deficiencies if any, along with mandatory disclosure and details of faculty recruited for each course in the prescribed format (available at AICTE wabsite (www.aicte.ernct.in) to the concerned Regional Office latest by 31st August, 2009 for consideration of approyal beyond the session 2009-10. It may be noted that all the institutions are required to submit the Compliance Report along with requisite processing fee by 31st August every year irrespective of the period of approval.

The Compliance Report roust be accompanied with a processing fee of Rs. 50,000/- in the form of a demand draft in favour of Member Secretary, AICTE payable at New Dethi. In the absence of processing fee, the Compliance Report will not be entertained. Following the Compliance Report, the Council would verify the status in respect of rectification of deficiencies through surprise/rendom inspection without any prior notice.

The above approval, if granted after rectification of deficiencies would be subject to the fulfillment of the following general conditions:

- That the management shall provide adequate funds for development of land and for providing related infrastructural, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
- (a) That the admission shall be made only after adequate infrastructure and all other facilities are provided as pdr norms and guidelines of the AICTE.
 - (b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
 - (c) That the curriculum of the course, the procedure for evaluation/ assessment of students shall be in accordance with the norms prescribed by the AICTE.
 - (d) That the institution shall not allow closure of the Institution or discontinuation of the course(s) or start any new course(s) or after intake capacity of seats without the prior approval of the Council.
 - (e) That no excess admission shall be made by the institution over and above the approved intake under any circumstances. In case, any excess admission is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution.
 - (f) That the institution shall not have any collaborative arrangements with any indian and/or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Course, appropriate penal action including withdrawal of approval shall be initiated against the Institution.

- (g) That the Institution shall not conduct any course(s) in the field of technical education in the same premises/ campus and/or in the name of the institution without prior permission/ approval of AICTE in case, any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution.
 - (h) The Institution shall not conduct any non-technical course(s) in the same premises/ campus under ay circumstances, in case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution.
- 3. That the institution shall operate only from the approved location, and that the institution shall not open any off campus study centres/ extension centres directly or in collaboration with any other Institution/ University organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.
- 4 That the fullion and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Connoil from time to time. No capitation fee shall be charged from the students/ guardians of students in any form.
- 5 That the accounts of the institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or any body or persons authorized by it.
- 6 That the Director/ Principal and the teaching and other staff shall be selected according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales as per the norms prescribed by the Council from time to time.
- 7.(a) That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.
- (b) That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institutions and courses/ programmes being conducted and details of infrastructural facilities including faculty etc in the form of mandatory disclosure. The information booklet may be made available to the staxeholders of the technical education on cost basis. The mandatory disclosure information shall be put on the institution website. The information shall be revised every year with updated information about all aspects of the institution.
- (c.) That it shall be mandatory for the technical institution to maintain a website providing the prescribed information. The website information must be continuously updated as and when changes take place.
- (d). That a compliance report in the prescriber format along with mandatory disclosures on fulfillment of the above conditions, shall be submitted each year by the institution within time limit prescribed by the Council from time to time.

- (e) That if Technical Institution fails to disclose the information or suppresses and/or misrepresents the information, appropriate action could be initiated including withdrawal of AICTE approval.
- 8 That all the laboratories, workshops etc. shall be equipped as per the syllabil of the Foreign University and shall be in operational condition before making admissions.
- 9 That a library shall be established with adequate number of titles, books, journals (both Indian & Foreign) etc. as per AICTE norms.
- That a computer centre with adequate number of terminals, printers etc. shall be established as per AICTE norms.
- 11. AICTE may carry, out random inspections round the year for verifying the status of the institutions to ensure maintenance of norms and standards.
- That the AICTE may also conduct inspections with or without notifying the dates to verify specific complaints of mis-representation, violation of norms and standards, mat-practices etc.
- 13. That the institution by virtue of the approval given by the Council shall not automatically become claimant to any grant-in-aid from the Central or State Government.
- 14. That in the event of a student/ candidate withdrawing before the starting of the course, the walt listed candidates should be given admission against the vacant seat. The entire fee collected from the student, after a deduction of the processing fee of not more than Rs. 1000/- (Rupees one thousand only) shall be refunded and returned by the Institution/ University to the student/ candidate withdrawing from the programme. It would not be permissible for Institutions and Universities to retain the School/ Institution Leaving Certificates in original for forced retention of admitted students. (See Public Notice AICTE/DPG/03(01/2008).
- 15. The Institute shall take appropriate measures for prevention of ragging in any form, in the light of directions of Suprame Court of India in Writ Petition No. (C) 656/1998, in case of failure to prevent the instances of ragging by the Institutions, the Council shall take appropriate action including withdrawal of approval.
- 16. That the institution shall provide the following facilities for the physically challenged persons:
 - Class rooms, toilets and hostels to be made accessible to wheel chair users.
 - b. Resource room for visually impaired students.
 - c. Accessible Library
 - d. Counseling Centre for disabled students.
 - e. Facility of sign language interpreter.
 - f. All students needing assistive devices to be provided such devices.

- That the Management shall strictly follow further conditions as may be specified by the Council from time to time.
